Yhtenä johtavista turvatuotteiden valmistajista Wuhanissa, Kiinassa 11 vuotta, valmistamme ja toimitamme tuotteitamme pääasiassa Eurooppaan, Pohjois- ja Etelä-Amerikkaan sekä Lähi-itään. 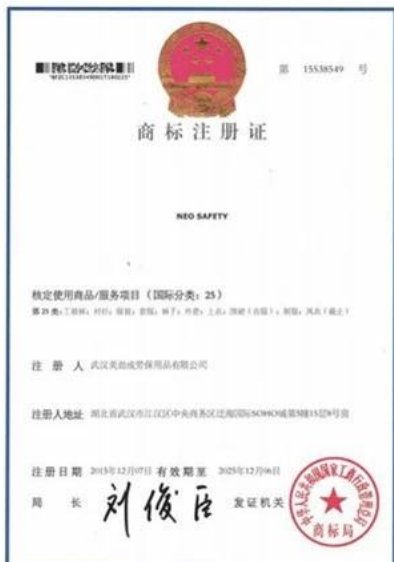
