Kilpailuedut:

Yhtenä johtavista turvatuotteiden valmistajista Wuhanissa, Kiinassa 13 vuotta, tuotamme ja toimitamme tuotteitamme pääasiassa Eurooppaan, Pohjois- ja Etelä-Amerikkaan sekä Lähi-itään. Kaksi mallisuunnittelijaa yli 20 vuoden kokemuksella. Uusin ohjelmisto kuvioiden tekemiseen, tehokas ja tarkka. Kahdeksan laadunvalvontatarkastajaa valvoo määrää leikkauksesta, ompelusta, pakkaamisesta, silityksestä koko matkan ajan, noin kaksisataa 10-15 vuoden kokemus työntekijöitä, vahvat vastuumekanismit.

1. Meillä on ammatillinen kokemus noin 11 vuotta, meidän maket sijaitsevat East Middle Maketissa, Etelä-Amerikassa, Euroopassa ja niin edelleen.
2. Meillä on suunnitteluosasto, mallimme kehittävät jatkuvasti uusia tuotteita markkinoiden kysynnän perusteella.
3. Ammattiteknikot antavat meille mahdollisuuden toimittaa tarkat näytteet asiakkaan vaatimusten mukaisesti ajoissa.
4. Kun tilaus on tehty, laadunvalvonta suoritetaan tiukasti alusta loppuun.
5. Valitsemme pätevät kankaiden, tarvikkeiden ja pakkausmateriaalien toimittajat.
6. Materiaali tarkastetaan tiukasti, kun ne saapuvat tehtaalle.
7. Vuotuinen tuotantokapasiteettimme on 100 000 ---- 120 000 kpl kuukaudessa.
